### Nannie Helen Burroughs Corridor Small Area Plan (NHBC-SAP)



The SAP is focusing on three priorities to create a vibrant and walkable mixed-use corridor with enhanced parks, green spaces, and multi-modal connections. The SAP will reflect the 2021 Comprehensive Plan Update.

- Provide guidance for new mixed-use development at key nodes along the corridor, including potential for additional housing, retail and commercial uses.
- Establish guidelines that support a socially active and equitable streetscape with a more human-scale.
- Create recommendations for better use, activation and connectivity of parks and green spaces along and adjacent to the corridor.

#### What We've Heard

## Housing & Economic Development Opportunities

- Maintain small town identity (5 stories)
- Draw visitors down the corridor
- Potential for catalytic investments (private or government)
  - Annual events drawing visitors
  - New homeownership opportunities
  - More residents increase demand to support retail (like grocery)
  - Community telework locations

## Public Realm/Urban Design Guidelines


- Transit hub along Nannie Helen Burroughs Ave
- Safety concerns inside parks and at connection points
- Flooding and storm water management issues
- Trash concerns
- Encourage businesses/owners to program adjacent public spaces
- Restore previous community public space activations

## **Green Spaces & Connectivity/History & Culture**

- Realize museum/tour potential
  - Walking/segway tours
  - Memorials and museums on school campuses
- Share history of bread factory, credit union, suburban yards, Dunbar/Nannie Helen Burroughs, local businesses
- "Everyone agrees on expanding park space and doing more historic/cultural preservation"



## **From Vision to Recommendations**



### **Conceptual Vision**

#### **Housing + Retail**

- Active ground floors and adjacent spaces with entertainment, retail, and dining with outdoor seating
- Support retention of existing businesses and new employment opportunities
- Engaging, human-scale facades that establish gateway entries
- Multi-unit housing providing a mix of market rate and affordable units supporting retail businesses
- Expanded access to homeownership for first time homebuyers

- Recommendations for commemorative subjects important to Deanwood





#### Recommendations based on what we have heard:



FOCUS: Develop connections throughout the neighborhood while expanding public space activities

- Connect and activate Nannie Helen Burroughs Avenue and Marvin Gaye Park
  - Locations for wayfinding tools through public art and commemorative works
  - Guidelines for buildings fronting corridor and park encouraging visual connections and an invitation to explore/linger
- Create a multimodal environment that is safe, comfortable and engaging for pedestrians

and concept for a commemorative work focusing on legacy
black entrepreneurs of Deanwood.

Black entrepreneurs provided goods and services to Deanwood when restrictive covenants contributed to segregation of neighborhoods and commercial businesses.

Deanwood was a neighborhood that prided itself on being a self-sufficient and built primarily by and for African American residents.

African American investors operated businesses at a time when financing for African American-owned businesses were limited.
