

PROJECT CONTEXT

This segment completes the middle section of a 9.9 mile rail-trail between downtown Franklinton and Louisburg. This project will link the existing Louisburg Bike Trail (2.2 miles) to the approximately 3 mile future rail-trail that will run from from downtown Franklinton to the Novozymes industrial park. This project shown "in development" on the map has slated funding by NCDOT.
