





### **Overall Program Cost Considerations**



#### **COST BASIS ASSUMPTIONS**

Original cost estimates (2019-2020) were based on 5% design and peer transit system comparison data

2022: costs have increased significantly (up to 70%-80%), due to the following drivers:



Right-of-way and real estate prices (Austin market)



Inflation, labor shortage, and anticipated supply chain barriers




Program scope changes as a result of community input and technical requirements (e.g. Tunnel length increase from 1.5 to 4 miles)





- Project phasing will be necessary to implement the program within available funding sources.
- Community input will be essential to defining project scope, phasing and next steps.


Tax increment rate will not be increased to cover ongoing program costs









#### **Capitol West / Government Center Station – Concourse Level and Section**






### Where we left off at 15%: Analysis Determined Orange Line Bridge over Lake Not Feasible







- Vertical climb in short distance is unfavorable
- Street conflicts: 2<sup>nd</sup> Street would need to be closed to traffic
- Utility conflicts between Lady Bird Lake and 3<sup>rd</sup> Street such as:
  - Water and wastewater mains
  - Storm sewer
  - Electrical vaults that support the high-rise towers
- Auditorium Shores FEMA Flood zone risk






### **Capitol View Corridor**



### How the Capitol View Corridor impacts tunnel length




- The Capitol View Corridor extends to Live Oak.
- To comply with state law, the first location the train can surface is south of that viewpoint (Live Oak St.).
- Tunnel extended 900 feet from previous long tunnel option.





### **Orange Line South Tunnel Design Progression**








#### **Auditorium Shores Station – URBAN CONNECTIVITY**















#### **Rainey / ESB-MACC Station – Concourse and Section**



#### **Rainey / ESB-MACC Station: Lady Bird Lake Entrance**









