TASK FORCE FEEDBACK



- Staff received concerns over attendance and task force balance

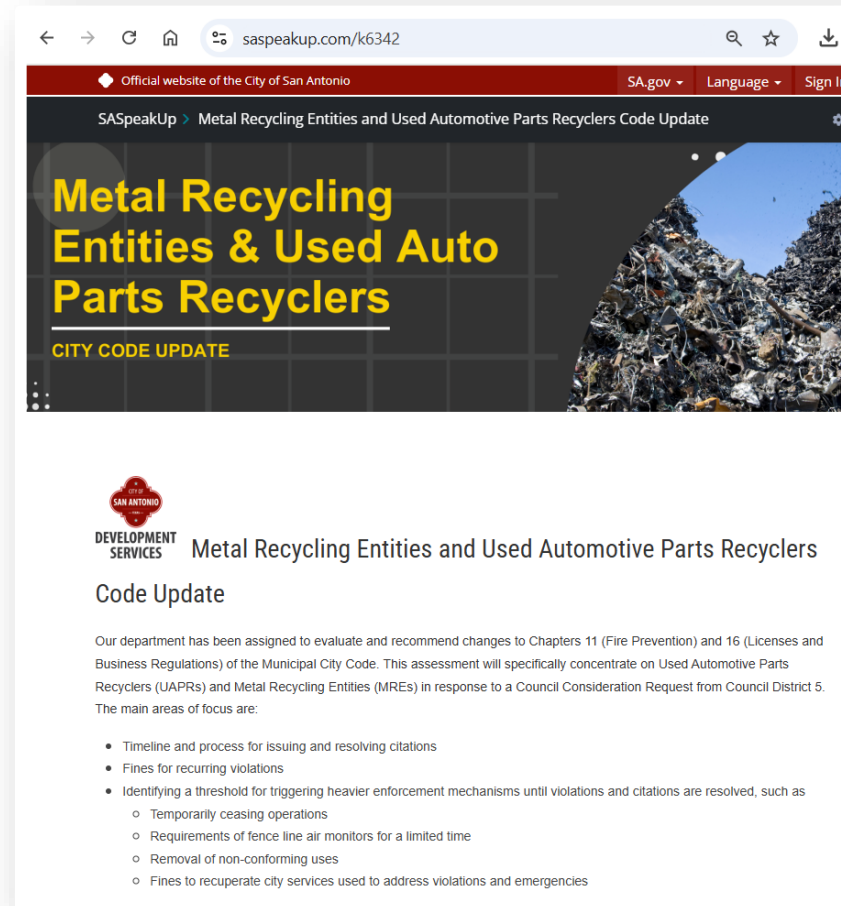
