PROJECT UPDATE

You are receiving this newsletter as a follow up to the January 2022 newsletter, which previously outlined the proposed relocation of N.C. 78 (Tramway Road) behind the VA Outpatient Clinic and Westfield Rehabilitation & Health Center.

The proposed relocation of Tramway Road has been removed from the U-5727 project and improvements will only occur along U.S. 1-15/501.

The graphic below represents the areas that remain part of the U-5727 project. The boundary is not representative of final construction impacts.

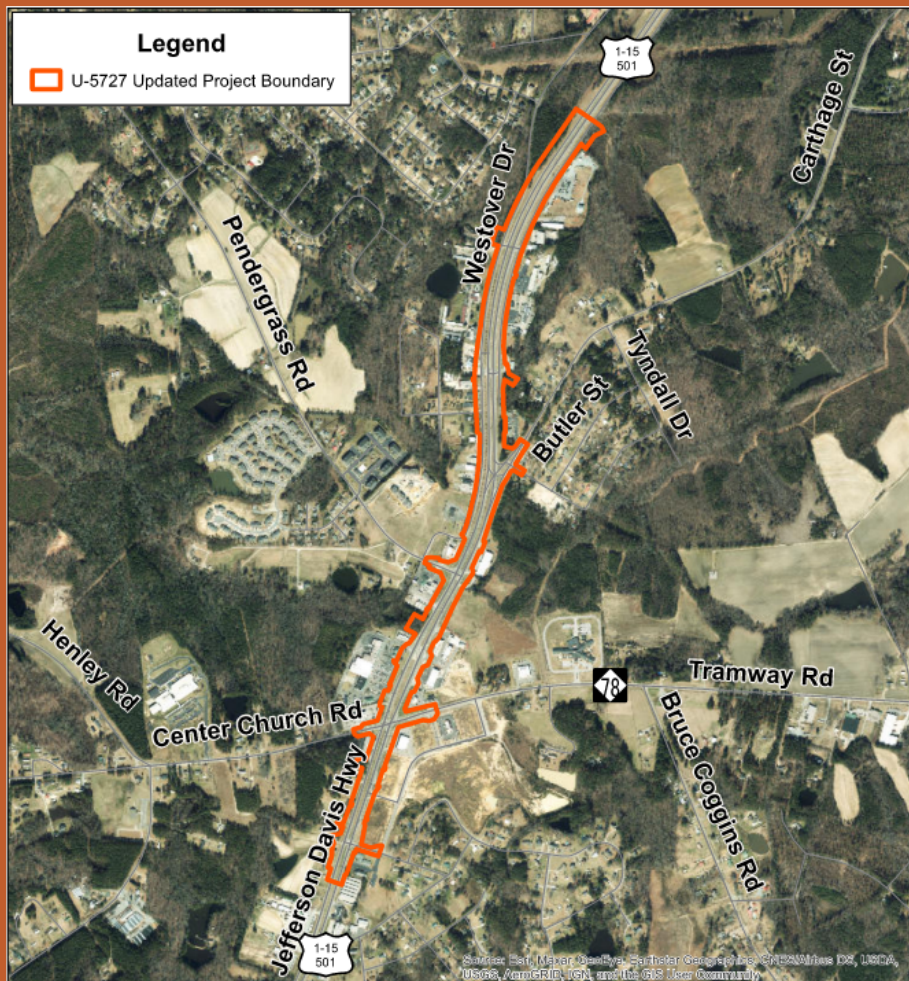
The N.C. Department of Transportation plans to improve intersections along the U.S. 1-15/501 corridor by converting them to reduced conflict intersections.

PROJECT BENEFITS

This project addresses the need to improve transportation network connectivity along U.S. 1-15/501 in southern Sanford. This project will relieve present and future traffic congestion and improve mobility and safety issues caused by the lack of access management and traffic flow issues.
