The commitment to equity in City contracts that is articulated in Resolution C is an admirable step in the right direction. However, inviting Black-owned businesses to compete for city contracts is not enough. In the case of Resolution I, no Black or Brown-owned businesses applied, and it's worth asking the City what resources they are making available to the Office of Business Inclusion to aid them in their outreach processes for soliciting bids. In the case of Resolution V, a Black-owned business did apply but did not receive the contract. Because of historical inequities in our community, larger white-owned businesses are often more well-established and thus able to out-bid smaller Black-owned companies, as was the case here. How is the City planning to remedy this?</p> <p>I also want to understand why the city is planning on signing a 5-year contract with a Taser services company?? And Regarding Resolution K: It's our understanding that the Office of Equity and Inclusion is no longer involved with business pertaining to the APD. Given that, what provisions will the City make to ensure that equity considerations are taken into account in selecting the trainers for the proposed de-escalation training? Noting that over \$2 million is being allocated to APD through this consent agenda, the majority is going to firearms, tasers, bulletproof vests, and bodycams. Less than 10% of that amount is going into things like a de-escalation training and mental health services for officers. Honor Black Asheville: REMOVE

~Too long, didn't read? What message would "repurposing" or "rededicating" send? Show Black community members you mean what you say. TEAR IT DOWN

To the majority of (read: white) tourists who pass through downtown on any given weekend without prior knowledge of WNC, Vance monument will likely only ever be a silhouette in a bustling landscape. They may never even be aware of the name Vance, let alone the history of the man, or the space the monument occupies.

The case seems similar for a number of mainly white residents I've heard comments from throughout this Public Input process and since the idea of re/moving Confederate monuments has emerged in the mainstream (read: white) zeitgeist. Though some who are local have more knowledge of history and context, the takeaway is clear: the landmark obelisk downtown holds pleasant memories of youthful nostalgia for MANY white people in this area. For them, this feeling outweighs the tremendous pain the very same site has caused for generations of Black citizens. This group of people cannot imagine their personal rose-tinted view of the past being deemed less important than the collective suffering and trauma of Black Asheville. It even seems impossible for some to hold that their personal experience may have differed from peers' of a different race, and that these experiences can both exist and be valid.

How can we possibly come to an agreement when we begin so far apart?

There are facts on which we agree: Zebulon Vance was an enslaver of human beings. We no longer wish to glorify people who owned other people like livestock. Unlike earlier statues placed mainly in cemeteries, monuments like Vance were not built as any kind of memorial to those lost in war. The history of Jim Crow era monuments has been thoroughly researched so we know with certainty those who built Confederate monuments intended them to overtly "teach values to people" and promote "glorification of the cause of the Civil War. That's why they put them in the city squares. That's why they put them in front of state buildings." -Prof. Mark Elliott, UNCG <https://www.history.com/news/how-the-u-s-got-so-many-confederate-monuments>

More directly, "Most of the people who were involved in erecting the monuments were not necessarily erecting a monument to the past. But were rather, erecting them toward a white supremacist future." - Assoc. Prof. Jane Dailey, University of Chicago <https://www.npr.org/2017/08/20/544266880/confederate-statues-were-built-to-further-a-white-supremacist-future>

We must hold these truths in common, or we would not be holding these discussions today. Now, wherever one finds themselves along this spectrum of views regarding Vance (be it a positive collection of memories meeting with loved ones downtown using the structure as a landmark, or benign- just another old stone standing among the throngs of people, to massively painful and traumatic every single time one must pass by, feeling the pain of knowing these stones celebrate a man and a culture that for so long bought and sold ancestors who looked just like the face in the mirror), we must all ask ourselves the same question.

As we seek to answer "Remove or Repurpose?", to whom do we owe an answer? And to whom do we want the answer to speak?

Black Asheville and WNC are LONG overdue an answer. We know the intention each of these stones was placed with. Each of these stones has meaning; a meaning that continues to harm Black people and POC in this community every day.

If the city carves into the stones, paints them, "adds context" or removes all traces of the name Vance and rededicates the existing obelisk, these stones still sit as intended.

You will have given your answer, and it will speak volumes.

Repurposing or rededicating simply allows the literal and symbolic foundation of this Jim Crow monument to continue. It sends a clear message to the entire community that white comfort is paramount; that those in charge will grant us small changes if we fuss enough, but in the end, the bedrock of supremacy stands.

For Asheville's progressive words to match our actions, the only option is to TEAR. IT. DOWN. Stone by stone, the weight of its history and meaning fully recognized so that we may move toward reconciliation.
