



### **Committee Purposes**

• Engage with community members and organizations to gain input regarding their experiences, insights, and recommendations on ways to improve the criminal justice system.

 Analyze input from the community to articulate recommendations, select target groups to be informed, and recommend priorities for the full Community Engagement Workgroup.



### **Action Steps**

- 1. Develop an action plan for the year to gain community input on criminal justice system reform
- 2. Identify community organizations and groups with which to partner in order to gain input from diverse populations in Buncombe County regarding the criminal justice system
- 3. Incorporate listening sessions, focus groups, and surveys into the action plan of the sub-committee
- 4. Conduct analyses of community input activities to gain critical insights and recommendations
- 5. Provide feedback loops to participating communities to test and modify analyses and recommendations, and ultimately make recommendations to the Community Engagement Workgroup
- 6. Transfer findings to the Communications Subcommittee for their work of informing the broader community and the criminal justice formal system
