## FY 25 AHSP Application Staff Summary: Eblen: Tenant Based Rental Assistance



**Project Description:** Eblen Charities (Eblen) has submitted a **Tenant Based Rental Assistance** application requesting grant funds in the amount of **\$126,000** to support tenant based rental assistance (TBRA) for income eligible individuals and families across Buncombe County.

AHSP Goal: Support activities that achieve functional zero Homelessness

**Summary**: Eblen's request (\$126,000) is intended to provide TBRA and case management services for income eligible residents (with special consideration given to older adults (65+), families that have been identified as McKinney-Vento, and families that are facing potential homelessness). The request will support 150 households with income <80% AMI across Buncombe County. The request will support an overall project budget of \$480,000 (to assist 1,108 households). Eblen has committed grant funding from Dogwood Health Trust and the Unbroken Spirit grant, totaling \$35,000. Additionally, Eblen has submitted, or is in the process of submitting, several applications to other sources for grant funding that if received, would total \$119,000 (\$107,000 additionally requested from Dogwood Health Trust, \$8,000 requested through a Publix Supermarket Grant, a \$10,000 request to be submitted to the Leon Levine Foundation, and a \$75,000 grant application to be submitted to the Duke Energy Foundation). Eblen is also actively fundraising and hopes to receive donations for the remaining \$119,000 for the project.

Eblen's TBRA program will assist qualified residents through providing funds for security deposits, utility assistance including deposits, initial rent payments, or back rent to mitigate homelessness and substandard living conditions.

Eblen's TBRA program currently does not operate with a waiting list. At time of application, Eblen had 18 application requests on hand awaiting determination from Buncombe County DHHS or needing to submit required documentation. Eblen receives 30 to 40 applications a month for TBRA. Eblen triages cases based on need, taking quick action if eviction papers have been served or if shut-off notices are given. Intake workers ensure applicants have an income or resources available to maintain the household at the time of application via income verification. Referrals to other agencies that aid residents are provided to applicants.

**Finance Department Assessment of Audits and Financial Position:** Eblen provided a relatively timely audit free of qualifications and findings. As of December 31, 2022, Eblen's financials show a reasonably healthy financial position.

**Recommendation**: Community Development Division staff reviewed the project, confirm it adheres to the requirements of the FY25 AHSP, and confirm it appears eligible for funding. The proposed project appears ready for implementation July 1, 2024. Consideration of full award is recommended given the ability to create immediate impact to Buncombe County households and to support Housing Choice Vouchers.
